## From the Chairman of the Kent Resource Partnership

Dear Mr Collins,

I am writing to you on behalf of the 13 Kent councils which make up the Kent Resource Partnership (KRP)<sup>1</sup>. One of our main responsibilities is working together to tackle waste crime, including fly tipping. Similarly to many areas across the country, fly tipping in Kent is:-

- Extremely costly to Kent taxpayers. Last year councils spent over £16m to deliver its streetscene services with over £1m spent on fly tipping clearances and taking forward investigations;
- Diverting councils' limited resources from other valuable frontline services such as helping the homeless community;
- Negatively impacting our natural environment. Countryside and local beauty spots within Kent are being blighted by unsightly dumping of waste; and
- Being predominately taken forward by organised crime groups. Fly tippers who are obtaining money from these fly tipping activities are likely to be funding far sinister criminal activities.

As you'll be aware, the maximum sentence for fly tipping in England at a Magistrates Court is £50,000 and/or a prison sentence of 12 months. At a Crown Court it can be an unlimited fine and/or a prison sentence of up to 5 years. We have recently taken forward a mini-review to understand the results councils' have achieved over the last 12 months, once fly tipping cases were at court. What was clear was outcomes were far less than the maximum punishments possible. For example, of the 57 cases in 2019/20, only one resulted in a prison sentence (of 20 weeks), most cases received a fine between £100-£499 with only four cases upwards of £2,000 and there was often low or no clean-up cost charges given to the offender.

We appreciate the details of these cases will vary and may have likely be presented differently across Kent but what is clear is the level of enforcement doesn't seem to do enough to deter offenders from committing waste crime.

With this in mind we wish to work with you on the following: -

- Arrange a virtual meeting between representatives from the KRP and Magistrates Association over the coming Summer;
- Better understand how sentencing on fly tipping is determined with magistrates' courts within Kent and understand if there are local differences councils ought to factor; and
- Establish the gaps councils' need to cover to achieve greater levels of enforcement punishment to fly tipping offenders, particularly those who are part of organised crime groups.

For information the proposed approach outlined above is supported by the National Farmers Union (NFU) who have provided their comments at the bottom of this letter.

What is clear is fly tipping will always remain an issue until meaningful consequences are handed to offenders. Potential offenders will always risk carrying out these crimes as long as they feel risk of being caught or enforcement punishment remains low. We believe such crimes should receive the appropriate enforcement action and working together we can make real change.
