A Day In The Life

The Organic Resource Agency (ORA) offers us a revealing glimpse into a day in the life of a waste management consultant...

08:30 – 09:30 As I pull into the office car park and glance at my watch, I am reminded of something I was told in a packed meeting once: “The problem with consultants is that they look at your watch and then tell you the time”. A quick Google indicates that the statement relied on borrowed wit. The full quote is “A consultant is someone who borrows your watch to tell you the time and then keeps your watch.” I have to admit that the analogy was a fun one to make, and have pondered how much truth there actually is in it.

The first hour of the day is the normal routine of checking e-mails and seeing what’s new within the industry. We maintain subscriptions to a number of print and electronic circulars and try to be aware of the general mood of the industry. Many of the articles have a similar post-Brexit theme of “what now?” and whilst buoyant and optimistic, there is a lot of uncertainty over how a myriad of decision points will finally be resolved.

With a responsibility for several clients on projects of varying scale and complexity, I tend to produce lists throughout the day. Lists for key information, lists for phone calls and e-mails, lists for appointments and meetings and lists for projects to develop. Our number one focus is our existing clients and the majority of our on-going work comes from demonstrating the usefulness of our current advice, a key focus of everything we do.

09:30 – 12:00 Having made a number of lists, it’s time to work through them. The next few hours pass by in a blur of phone calls and emails. Site “A” needs a full review of their environmental containment system. Site “B” is ramping up feed to their anaerobic digestion facility and requires the feedstock properties verifying. A colleague calls to discuss some health and safety issues and also to compare notes on acceptance test procedures. In-house, we cover a wide

approach to our consultancy advice and means that team working is essential. With projects across the whole of the UK we maintain a number of satellite offices so scheduled team meetings help to avoid the team becoming fragmented, and regular “check-ins” allow us time to provide updates across critical issues.

12:00 – 15:00 I’m still waiting for someone to develop a lunch every bit as convenient, but not as boring, as a sandwich. Lunch is eaten on the way to a site meeting. Despite the technology that allows conference calls with audio and video, it’s still a fact that nothing is quite as useful as a face-to-face meeting. There is a lot to be said for setting aside time to sit around a table with both the right information and the right people when progress is required. We strive to ensure that our clients obtain the right result for their business and that they can be confident that in their interactions with third parties they are receiving accurate and useful information.

15:00 – 17:30 Back in the office again and there is a little time after responding to e-mails and circulating meeting notes to consider my first thought of the day: “what value do consultants bring to projects?” I glance at my watch, again – it has three hands and the date displayed on the face. I’m not sure that even the most complex of watches encompasses the variety of information that needs to be understood in the changeable world of waste management. My role in helping move the industry forward is to be across as much information as is available and ensure the lessons learned are applied, or to put it in other words, to make sure I give the watch back! ■
